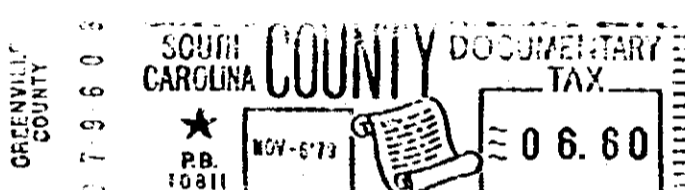
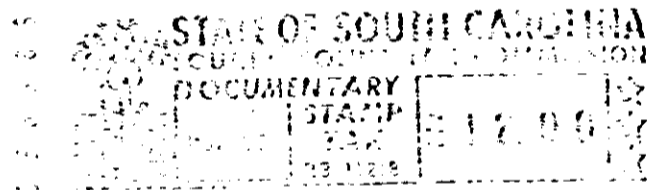
That certain lot of land, with all improvements now or hereafter placed thereon, in Chick Springs Township, said County and State, and having the following courses and distances, to-wit:
