ALL that certain piece, parcel or tract of land with improvements thereon, lying, being and situated in the State of South Carolina, County of Greenville, on the Southern side of Heritage Drive containing 2.26 acres, and being known as Tract 13 of Heritage Estates reflected on plat made by J.
