and release unto JOHN A. BOLEN, INC., its successors and assigns forever:

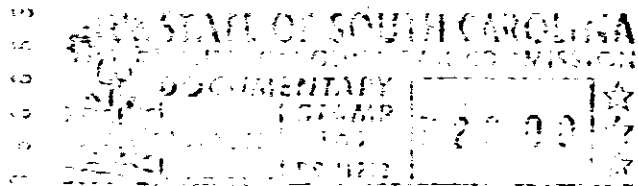
