**DURABLE
POWER OF ATTORNEY**

I, the undersigned, a resident of said County and State aforesaid, do hereby nominate, constitute and appoint MATTIE BOWEN TZOUVELEKAS as my attorney-in-fact to act for me in my behalf and in my stead.

It is understood that this is a complete power of attorney to do any act, which is legal, in my behalf and in my stead.

I do hereby ratify and confirm all of the acts which my attorney-in-fact may do under this instrument. I do further relieve any purchaser, mortgagee or any other person in the nature of a third party, coming into contact with this instrument, from any and all liability to check into the matter or to see to the use or application of any proceeds or any other matters pertaining thereto.

This power of attorney shall not be affected by physical disability or mental incompetence of the principal, which renders the principal incapable of managing the principal's own estate.
