KNOW ALL MEN BY THESE PRESENTS, that I, Delk G. Traynham, of Greenville County, South Carolina, do hereby make, constitute and appoint Laura T. Coleman, of South Carolina, my true and lawful attorney for me and in my name, and stead to do as fully and effectually any and every act and deed and all acts and deeds, without exception, limitation, or restriction, that I myself might or could do if personally present, including, but without in any manner limiting, qualifying, or restricting the all-inclusive nature of the foregoing authority and power, the power to control, manage, carry on, and operate all my affairs and businesses, and to do all things and to transact all business required to be done or transacted in connection or with any part thereof; to exercise all rights of ownership in property now or hereafter owned by me; to acquire property; to demand, sue for, collect, receive, and give good receipts, acquittances, discharges, and satisfactions for all monies, debts, interests, dividends, accounts, receivables, claims, and demands, and other personal property of every kind and description due or owing or belonging to me or to which I am or may or shall be entitled; to compromise and settle claims due to or by me; to sell, assign, transfer, convey, and dispose of any and all property, real and personal, now or hereafter owned by me; to borrow money and to give security by mortgage, pledge, or otherwise of any or all property now or hereafter owned by me; to renew or otherwise extend the time for payment of any note or other obligation that may or shall be due and owing by me; to endorse and either cash or deposit any check or draft or other instrument for payment of any money payable to me or to withdraw by check or draft any money to my credit or account in any banking institution or savings and loan association; to prepare, make, sign, and file any and all tax returns of any and every kind and description, including Federal and State income tax returns, required to be prepared, made, signed or filed by me and to act for me in all matters relating to or pertaining to or arising out of any such return and to my liability for taxes as shown thereby; and to make, sign, and execute all deeds, contracts, notes, mortgages, and other papers with such covenants and warranties, if any, as to her may seem advisable; I hereby ratify and confirm any and all acts and deeds that my said attorney shall do or cause to be done by virtue of these presents. This Power of Attorney shall not be affected by the physical disability or mental incapacity of the Principal which would render the Principal incapable of managing his estate.
