GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, WALTER H. LEEDOM, of Greenville, South Carolina, hereby revoking all powers of attorney at any time heretofore made by me, do hereby constitute and appoint IDA MAE DuBOIS my true and lawful attorney, for me and in my name and stead, to receive payment of dividends, interest and monies; sign, endorse and cash checks; give receipts; make and execute sales, assignments and conveyances of any property, real, personal or mixed, or any rights in property which I may now have or to which I may hereafter become entitled; to vote any stock which may stand in my name on the books of any corporation, and from time to time to execute proxies for the voting thereof; to consent on my behalf to any corporate action; to sign and file on my behalf any and all income tax returns or papers incident thereto; to sign checks on any bank accounts standing in my name for any purpose she may deem proper; to have specific authority to open at any time and from time to time any safety deposit box listed in my name, and to remove therefrom any stocks, securities, notes, bonds, and any other items of every kind and nature which may be kept in said safety deposit box, and to give such receipts therefor as any bank or other institution may require; and generally to do and transact for me and in my name any and all business of every kind and nature as fully as I might do if personally present and acting in my own behalf.

This power of attorney shall not be affected by physical disability or mental incompetence of the principal which renders the principal incapable of managing his own estate.

I, as principal, do hereby further expressly declare that at any time after the onset of my mental disability, my attorney in fact shall not be required to (a) file an inventory of my deposits, choses in action or personal property with any probate, or other court, or (b) post any surety bond with any probate, or other court.

This power of attorney shall continue in effect until revoked in writing by me.
