BEGINNING at an iron pin on the northwestern side of Fairlawn Circle, at the joint front corner of Lots 20 and 21 and running thence along the joint line of said Lots, N 22-15 W, 192.0 feet to an iron pin on the line of Lot 24; thence along the line of that lot, S 60-00 E, 45.0 feet to an iron pin, joint rear corner of Lots 21, 22 and 24; thence along the joint line of Lots 21 and 22, S 19-13 W, 177.0 feet to an iron pin on the northwestern side of Fairlawn Circle; thence along the northwestern side of Fairlawn Circle, following the curvature thereof, the chords being S 61-07 E, 57.0 feet; N 83-00 E, 58.8 feet and N 62-27 E, 70.0 feet to the beginning corner.
