All that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the corporate limits of the City of Greenville, being known and designated as Lot No. 29 of a subdivision known as Stone Lake Heights, Section No. 4, as shown on plat thereof prepared by Piedmont Engineers and Architects on July 8, 1964, revised in October, 1965, and recorded in the R.M.C. BEGINNING at an iron pin on the northern side of Ashford Avenue at joint front corners of Lots Nos. 29 and 30 and running thence along the northern side of Ashford Avenue, S. 50-14 W. 137.0 feet to an iron pin at a corner of Lot No. 28; thence along the line of that lot and continuing along the line of Lot No. 27, N. 27-10 W. 157.7 feet to an iron pin at a rear corner of Lot No. 33; thence along the line of that Lot, N. 57-29 E. 117.2 feet to an iron pin at a rear corner of Lot No. 30; thence along the line of that Lot, S. 34-14 E. 140.3 feet to the beginning corner.
