the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and
release unto Gary Randal Watkins and Jennifer Kaye Watkins their heirs and assigns forever;
an undivided one-half interest in and to:

ALL those pieces, parcels or lots of land situate, lying and being on the northwestern side
of Regent Drive, in Paris Mountain Township, near the City of Greenville, County of Green-
ville, State of South Carolina, being known and designated as Lots Nos. 56 and 57 of a sub-
division known as Edgefield, and having, in the aggregate, according to a plat of said sub-
division, prepared by Piedmont Engineering Service, dated March 1957, revised September 1957,
and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book NN at Page
195, the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Regent Drive at the joint front corner of
Lots Nos. 55 and 56 and running thence with the line of Lot No. 55, No. 49-15 W. 213.5 feet
to an iron pin; thence S. 42-47 W. 127.6 feet to an iron pin in the rear line of Lot No. 57;
thence S. 35-29 W. 72.9 feet to an iron pin at the joint rear corner of Lots Nos. 57 and 58;
thence with the line of Lot No. 58, S. 49-15 E. 210.9 feet to an iron pin on the northwestern
side of Regent Drive; thence with the northwestern side of Regent Drive, N. 40-45 E. 200 feet
to the point of beginning; being the same conveyed to us by Furman University by deed dated
June 11, 1968, and recorded in the RMC Office for Greenville County in Deed Vol. 845, Page 636.

THIS conveyance is made subject to "Protective Covenants Applicable to Edgefield" recorded in
the RMC Office for Greenville County in Deed Book 576 at Page 149; to "Amendment to Protective
Covenants Applicable to Edgefield" recorded in the RMC Office for Greenville County in Deed
Book 587 at Page 178; and to drainage and utility easements, including water lines (if any)
shown on the aforesaid plat.

AS a part of the consideration for this conveyance, the grantees expressly assume and agree
to pay 1/2 the balance due on that certain note and mortgage, in the original sum of \$23,200.00
given to Fidelity Federal Savings and Loan Association of Greenville and recorded in the RMC
