


ALL those certain pieces, parcels or tracts of land, located, lying and being in the County of Greenville, State of South Carolina, lying on the Northern side of Tubbs Mountain Road, being known and designated as Tract 3, containing 2.11 acres, more or less, and Tract 3A, containing 0.37 acre, more or less, for a total of 2.48 acres, more or less, as shown on survey entitled "Property of Paul Hunt", prepared by W.
