the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
S. Norman Greene and Beth M. Greene, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about two miles north of Greer, on the South Side of the Apalache Road, and being bounded on the East by lands of Mrs. M. H. Suddeth, and on the South, West, and North by other lands of J. A. Burnett, and having the following courses and distances:
