to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto KRIEGER DEVELOPMENT COMPANY, a South Carolina general partnership (whose partners are Karen Lisa Krieger, Kenneth Michael Krieger, and Robert Mitchell Krieger), its successors and assigns forever:

ALL that certain piece, parcel or lot of land, situate, lying and being on the southern side of Tigerville Road in or near the Town of Travelers Rest, Greenville County, South Carolina, being shown and designated as Lot No. 13 and the 50-foot strip immediately to the rear of said lot being shown as a portion of Woodvale Avenue on plat entitled "Plat of Estate of James G. Morgan" dated August 1-4, 1964 by Terry T. Dill, recorded in the RMC Office for Greenville County in Plat Book BBB, Page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern right of way of Tigerville Road at the northeastern corner of other property now owned by the Grantee herein (said pin being located 401.7 feet from the eastern right of way of U. S. Highway No. 25) and running thence with the line of other property now owned by the Grantee herein, S. 0-15 W. 300 feet to an iron pin at the rear of Lot 13; thence continuing in the same direction, 50.1 feet to an iron pin; thence running with the southern line of the 50-foot strip designated as Woodvale Avenue on the above referred to plat, which line is also the boundary line of other property of the Grantee herein, S. 86-11 E. 183 feet to a point; thence turning and running N. 0-15 E. 50 feet, more or less, to an iron pin at the joint rear corner of Lots 12 and 13 as shown on the above referred to plat; thence with the joint line of Lots 12 and 13, N. 0-15 E. 300 feet to an iron pin on the southern side of Tigerville Road; thence with Tigerville Road, N. 86-07 W. 183 feet to the Point of Beginning. — 8-367-503.2-1-49
