ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, located on the Western side of an unnamed street (sometimes referred to as Crosby Circle and sometimes referred to as MacKenzie Road), being shown and designated as lots 13 and 14 on a plat entitled "Blue Sky Park", dated June, 1948, by C.C. Jones, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book S at page 83, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of said road at the joint front corner of Lot 14 with Lot 1, and running thence with the joint line of said Lots, N80-30W 150 feet to a point at the joint line with Lot No. 2; thence with the joint lines of Lots 14 and 13 with Lot No. 2, N9-30E 100 feet to an iron pin at the joint rear corner with lot No. 12; thence with the joint line with Lot 12, S80-30E 150 feet to an iron pin on the western edge of said road; thence with the western edge of said road, S9-30W 100 feet to the point of - 19- 100- 593,1-3-13,14 beginning.
