to an iron stake; thence running in a westerly direction along the rear line of Lot 3, 60 feet to an iron stake on the common corners of Lots 2 and 3; thence running in a southerly direction 85 feet to the beginning corner. There being granted a right-of-way or easements granted with the hereinabove described lot; said right-of-way frunning from the said stake on the said Arch Street Extension and running thence with the common line of Lots 2 and 3 in a northerly direction 85 feet to the beginning stake of the abovedescribed lot and extending 15 feet in an easterly direction along the entire length of the 85 foot line. Said right of way or easement granted for the purpose of ingress, egress and regress to the above described lot. Being conveyed unto Grantor herein by deed of Modern Homes Construction Company, dated January 9, 1964, recorded in Deed Book 741, at page 49 in the Office of the Clerk of Court for Greenville County, S. #2) ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being the southerly portion of Lot #3 as shown on a plat of the property of F. B. Massingale recorded in the R.M.C. Office for Greenville County in Plat Book W, at page 109, and having according to said plat the following metes and bounds, to-wit: BEGINNING at a stake on the northerly side of Arch Street Extension at the joint front corner of Lots #3 and 4 and running thence in a northwesterly direction with the line of Lot #4, 85 feet to a point in line of other property of Ruby Paris; thence S60-40W 60 feet to a point in the line of Lot #2; thence with the line of Lot #2 in a southwesterly direction 85 feet to a point on the northwesterly side of Arch Street Extension; thence with said street, 60 feet to the point of beginning.
