ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, Chick Springs Township, lying on the western side of Oakleaf Road, being shown and designated as Lot No. 6 on a plat of Oakleaf, Property of Real Estate Investments, Inc., prepared by C.
