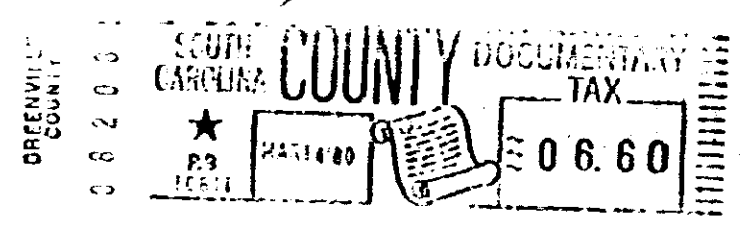
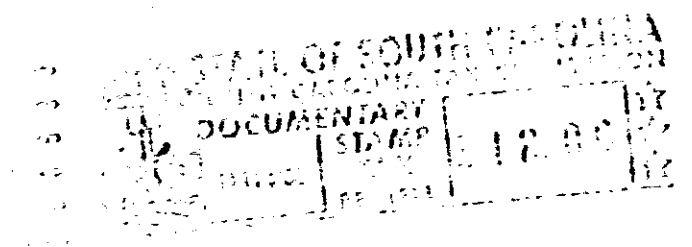
KNOW ALL MEN BY THESE PRESENTS, that **LEROY CANNON REALTY, INC.**

Six Thousand & No/100 (\$6,000.00)----- Dollars,
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto
WILLIAM LEE HOWELL & MARY A. HOWELL, their heirs and assigns forever:

ALL that certain piece, parcel and lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 16, of Cannon Estates, Section II., containing 1.71 acres more or less, according to a plat prepared by Charles K. Dunn and T. Craig Keith Associates, R.L.S., dated February 3, 1979, and being recorded in the R.M.C. Office for Greenville County, S. C. In Plat Book 7C at page 14, and having according to said plat the following metes and bounds to-wit:

BEGINNING at the joint front corner of Lots 16 and 15 on Garrison Road (S 23-272) and running thence with said Lots, N. 05-54 W. 362.3 feet to an iron pin at the joint rear corner of said lots; thence running along the rear lot line of Lot No. 16 and Lot No. 12, S. 84-35 W. 160.05 feet to an iron pin; thence running with the lot line of Lots 16 and 17, S. 17-35 W. 281.05 feet to an iron pin on West Georgia Road (S 23-541); thence along West Georgia Road, the following courses and distances; S. 61-46 E. 37.04 feet to an iron pin; thence S. 65-33 E. 111.54 feet; thence S. 83-57 E. 45.35 feet to an iron pin; thence N. 75-46 E. 60 feet to an iron pin at the beginning corner.

This conveyance is made subject to the recorded Restrictions in Greenville County in Deed Book 1099 at page 7 and to a joint agreement between Jack Huff and Leroy Cannon dated January 10, 1979 as to the rear property line and any other recorded easements and rights of way and any visible on the property.
