in consideration of Nine Thousand Five Hundred and No/100 (\$9,500.00) and the Dollars assumption of the mortgage indebtedness set forth below----- the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto RAYMOND N. CAMPBELL and SHIRLEY T. CAMPBELL, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land, located, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 40 on plat entitled "Collins Creek, Section One", dated July 30, 1979, prepared by C. O. Riddle, Surveyor, recorded in the Greenville County RMC office in Plat Book 7-C at Page 56, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Northern side of the right-of-way of Collins Creek, at the joint front corner of the within lot and Lot No. 39 and running thence, along said right-of-way N. 61-02 W., 191.57 feet to a point at the joint front corner of the within lot and Lot No. 41; thence, running along the joint line of said lots N. 37-01 E., 250.27 feet to a point at the joint rear corner of the within lot and Lot No. 41; thence, S. 60-45 E., 119.18 feet to a point; thence S. 20-22 W., 250.05 feet to a point at the joint front corner of the within lot and Lot No. 39, on the Northern side of the right-of-way of Collins Creek, the point and place of beginning.
