KNOW ALL MEN BY THESE PRESENTS, that we, Frank Towers Rice and Greg L. Turner,

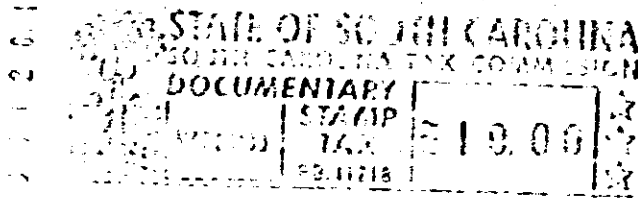
in consideration of Nine Thousand Five Hundred and No/100 (\$9,500.00)---- Dollars,
