to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto M. G. PROFFITT, INC., its Successors and Assigns forever:

ALL that certain piece, parcel, or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Sugarcane Court near the City of Greenville, South Carolina, being known and designated as Lot No. 14 on plat entitled "Map 7, Sugar Creek," as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-C at Page 15, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Sugarcane Court, said pin being the joint front corner of Lots 14 and 15 and running thence with the common line of said lots S. 84-22-45 W., 137.5 feet to an iron pin, the joint rear corner of Lots 14 and 15; thence S. 5-37-15 E., 100 feet to an iron pin, the joint rear corner of Lots 13 and 14; thence with the common line of said lots N. 84-22-45 E., 137.5 feet to an iron pin on the westerly side of Sugarcane Court; thence with the westerly side of Sugarcane Court N. 5-37-15 W., 100 feet to an iron pin, the point of beginning.
