KNOW ALL MEN BY THESE PRESENTS, that M. G. PROFFITT, INC.,
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at
Greenville, State of South Carolina, in consideration of One Hundred Two Thousand Five
Hundred & 00/100 (\$102,500.00) ----- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto MAURICE A. PURCELL and SUSAN K. PURCELL, their Heirs and Assigns forever:

ALL that certain piece, parcel, or lot of land with the buildings and improvements
thereon, lying and being on the westerly side of Sugarcane Court near the City of
Greenville, South Carolina, being known and designated as Lot No. 14 on plat entitled
"Map 7, Sugar Creek," as recorded in the RMC Office for Greenville County, South
Carolina, in Plat Book 7-C at Page 15, and having, according to said plat, the follow-
ing metes and bounds, to-wit:

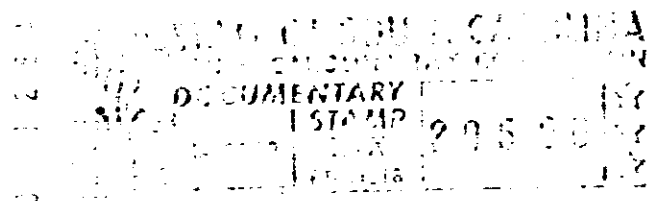
BEGINNING at an iron pin on the westerly side of Sugarcane Court, said pin being the

iron pin on the westerly side of Sugarcane Court; thence with the westerly side of
Sugarcane Court N. 5-37-15 W., 100 feet to an iron pin, the point of beginning.
