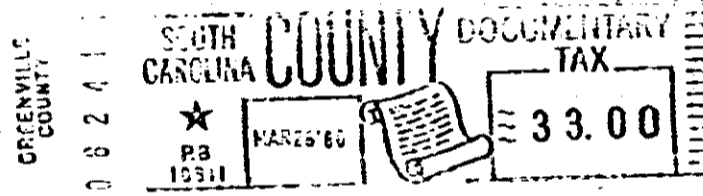
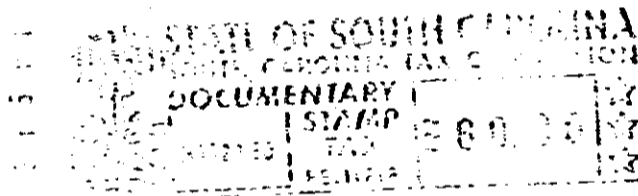
in consideration of Twenty-nine thousand nine hundred (\$29,900.00) Dollars,
