and release unto Essie D. Irby, her heirs and assigns, forever:

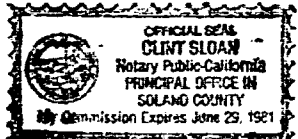
All that certain piece, parcel or lot of land situate on the southern side of Talley
