KNOW ALL MEN BY THESE PRESENTS, that I, Joseph R. Swedish

in consideration of Fifty-Five Thousand Five Hundred and No/100 (\$55,500.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thomas A. Lawson and Bernice G. Lawson, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Southeasterly side of Dellwood Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 159 and a 5' strip of Lot No. 160 of the property of Central Development Corporation as shown on a plat recorded in the RMC Office for Greenville County, South Carolina, in Plat Book BB at pages 22 and 23, and having, according to a more recent survey entitled "Property of Joseph R. Swedish" prepared by Charles F. Webb, RLS, dated May 19, 1979, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Dellwood Drive, said pin being the joint front corner of Lots 158 and 159 and running thence with the common line of said lots S. 27-34 E. 216.2 feet to a point in the center of a branch, thence with the center of the branch as the line, the traverse of which is N. 77-04 W. 98.65 feet to a point in the center of the branch, thence continuing with the center of the branch as the line, the traverse of which is S. 47-16 W. 5.18 feet to an iron pin, thence on a new line through Lot 160 N. 27-34 W. 155.45 feet to an iron pin on the Southerly side of Dellwood Drive, thence with the Southerly side of Dellwood Drive N. 62-26 E. 80 feet to an iron pin, the point of the beginning.

The foregoing conveyance is specifically made subject to Restrictions recorded in the RMC Office aforesaid in Deed Book 444 at page 429 and Deed Book 451 at page 105.
