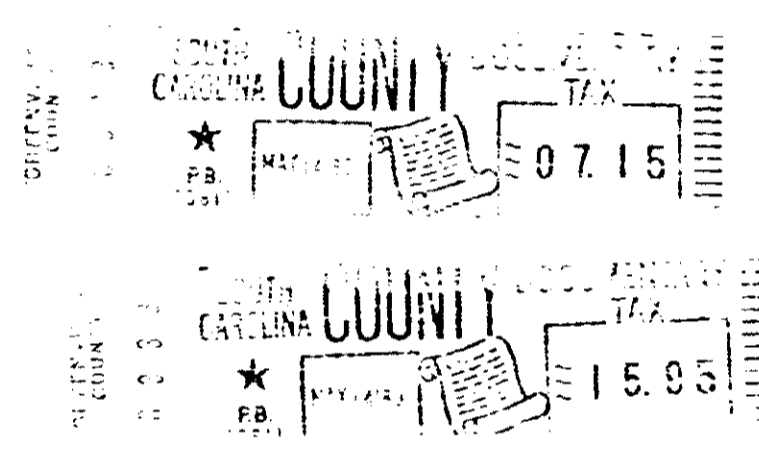
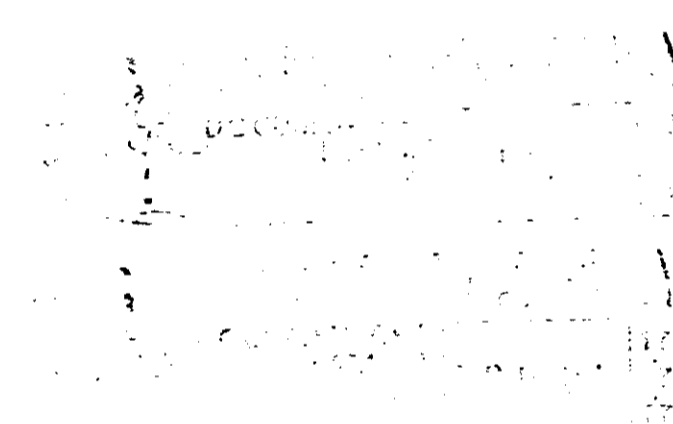
KNOW ALL MEN BY THESE PRESENTS, that Irene G. Herran
