AND TO THE FOLLOWING DESCRIBED REAL ESTATE:

ALL those pieces, parcels and lots of land with the improvements thereon, located in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Tract No. 4, containing 3.20 acres, more or less; and Tract No. 8, containing 0.50 acres on plat of property of George E. Brown Estate, dated October 13, 1978 by C. O. Riddle, Registered Surveyor No. 1347, and having according to said plat the following metes and bounds:
