the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James R. McClain, his heirs and assigns,

"ALL that piece, parcel or tract of land situate, lying and being in Bates Township, County of Greenville, State of South Carolina, located on the Northerly side of a County road and being more particularly described according to a survey and plat of property of James R. McClain made by Terry T. Dill, Surveyor, dated October 8, 1978, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a County road, which pin is located 88 feet East of the intersection of said County road with Jones Kelley Road and running thence N. 47-07 W. 740 feet to an iron pin; thence S. 42-53 W. 165 feet to an iron pin; thence N. 47-07 W. 278 feet to an iron pin; thence N. 53-00 E. 325 feet to an iron pin; thence S. 42-50 E. 363 feet to an iron pin, thence S. 51-47 E. 503 feet to an iron pin in the center of a County road; thence along the center of said County road S. 16-22 W. 92 feet to an iron pin; thence continuing along the center of said road S. 08-03 W. 100 feet to an iron pin, the BEGINNING corner, and containing 4 acres, more or less."

This conveyance is made subject to all restrictions, set back lines, roadways, zoning ordinances, easements and rights-of-way, if any, affecting the above described property.
