(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HERMAN JONES, RUSSELL RIGDON, DR. VERNON MUSTIAN and REV. PAUL R. TAYLOR, Trustees under written Trust Agreement dated June 30, 1976, their successors and assigns:
