Known All Men by These Presents:

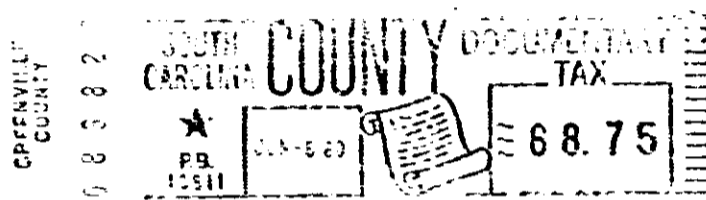
