ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being Lots Nos. 18 and 19 of Property of F. B. Massingale made by J. Coke Smith, May 15, 1947, and having the following metes and bounds, according to said plat:

BEGINNING at a stake on the South side of Arch Street Extension, at corner of Arch Street, and running thence in an Easterly direction with the South side of Arch Street Extension, 108.5 feet to a stake at corner of Lot No. 20; thence in a Southerly direction with line of Lot No. 20, 232.3 feet to a stake near the Bramlett Road; thence S. 60-25 W., 148 feet to a stake on Arch Street; and thence with Arch Street in a Northerly direction 236 feet to the beginning corner.
