the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William H. Mellman, his heirs and assigns forever; an undivided one-third (1/3) interest;

All that piece, parcel or lot of land situate, lying and being on the south side of Park Avenue, in the City of Greenville, County and State aforesaid.

BEGINNING at a stake three hundred and seventy-five (375) feet from the corner of Park Avenue and Vannoy Street, and running thence in a southerly direction one hundred and ninety eight (198) feet to a stake, joint corners of Lots Nos. 14 and 15; thence in an easterly direction seventy-one and two tenths (71.2) feet (erroniously state in deed of W. C. Cleveland to Elizabeth Stevens as seventy (70' 2'') feet and two inches), to a stake at corner of Lots 15 and 16; thence with dividing line of Lots Nos. 15 and 16 in a northerly direction two hundred and eleven (211) feet and two (2) inches to a stake on Park Avenue; thence with Park Avenue in a westerly direction seventy (70) feet to the beginning corner, and being known as Lot.
