and release unto Clarence S. Wutke and Elizabeth Ann Wutke, their heirs and assigns forever;

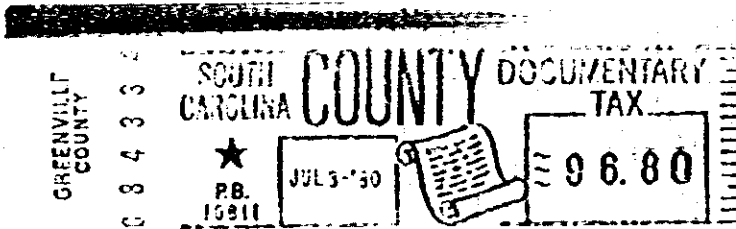
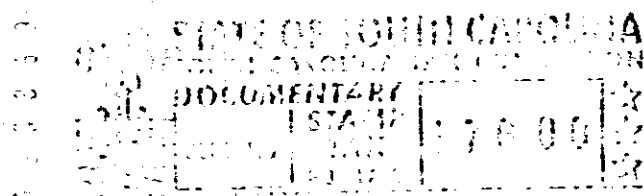
ALL that certain piece, parcel or lot of land situate, lying and being in the County of
