to in hand paid at and before the sealing of these presents by Joe Lee Sitton and John H. Sitton, III

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents

do grant, bargain, sell and release unto the said Joe Lee Sitton and John H. Sitton, III share and share alike, their heirs and assigns forever, an undivided one-fourth (1/4) interest each in and to:

ALL that certain piece, parcel or lot of land situated, lying and being in the City of Greenville, in the County and State aforesaid on the East side of Richardson Street and having the following metes and bounds to-wit:

BEGINNING at an iron pin on Richardson Street and running thence with said Street S. 20 W. fifty (50) feet to an iron pin; thence S. 70 E. one hundred (100) feet to an iron pin on Gowers line; thence with Gowers line N. 20 E. fifty (50) feet to an iron pin; thence N. 70 W. one hundred (100) feet to the beginning corner. The last named corner being one hundred and fifty (150) feet from Washington Street.
