release unto JOHN R. DONAHUE AND DIANE M. DONAHUE, their Heirs and Assigns forever:

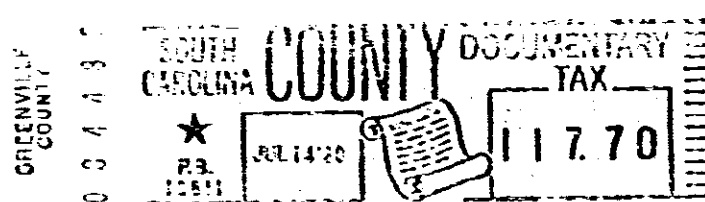
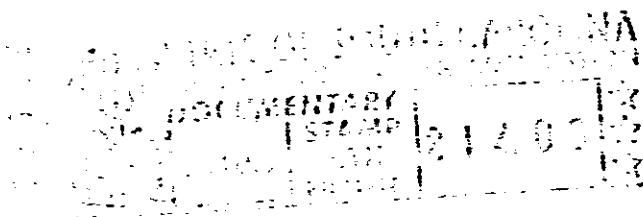
ALL that certain piece, parcel, or lot of land with the buildings and improvements thereon,
