Stone, Jr., all my right, title and interest in and to the following described property, to-wit:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Ward Two of the City of Greenville on the west side of Rowley Street, and being known and designated as the northern half of Lot No. 38 of a subdivision of the property of the Stone Land Company as shown on plat thereof made by J.
