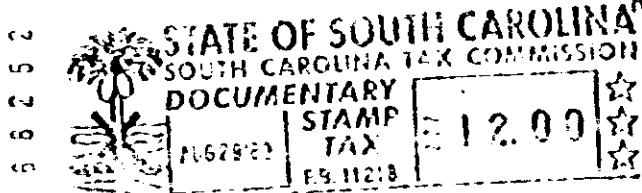

County, State of South Carolina, Town of Fountain Inn, fronting on Jones Street,  
 and being more fully described in accordance with plat made by Jones &
