Tract No. Two

ALL that piece, parcel or lot of land in Saluda Township, Greenville County, South Carolina, containing 190.60 acres, and according to a survey of record in the RMC office for Greenville County, SC, in Plat Book M, at Page 43, having the following metes and bounds, to-wit:

Tract No. Three
