the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto EVELYN SOUTHERN BLACKWELL, her heirs and assigns, forever,

ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the western side of Third Avenue in Section 2 of Judson Mill Village, in County of Greenville, State of South Carolina, designated as Lot #6, on plat of Section 2 of Judson Mills Village, made by Dalton & Neves, Engineers, November 1939, which plat is recorded in R.M.C.
