ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, near Travelers Rest, being shown as 2.7 acres on plat entitled "Property of Evelyn B. McFalls" prepared by W. R. Willaims, Jr., surveyor, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of Allen Road (which iron pin is approximately 2,500 feet from Highway 25) thence N.75-37 W., 82 feet to an iron pin; thence N. 42-55 W., 227.8 feet to an iron pin; thence N. 51-54 W., 92.2 feet to an iron pin; thence N. 59-13 E., 516.4 feet to an iron pin; thence S. 24-23 E., 225 feet to an old iron pin and stone; thence S.60-34 W., 260 feet to an old stone; thence S.0-59 W., 175.7 feet to an iron pin being the point of beginning.

3. Single-wide mobile home not allowed. Double wide allowed on permanent brick or block foundation, 24 inch minimum ground clearance at lowest point required. Minimum double wide trailer size 24feet X 55 feet.
4. Temporary single wide mobile home allowed during construction of house. This mobile home can only be set up after foundation for permanent house is constructed. A maximum of one year is allowed for the temporary mobile home.
