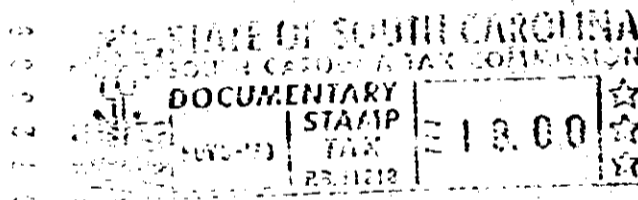
All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 9, as shown on plat of the subdivision of HENDERSON FOREST, which is recorded in the Office of the RMC for Greenville County, South Carolina, in plat book 4-R, at page 41, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Glenda Lane, at the joint front corners of Lots No. 9 and 10 and running thence with the joint line of said lots, S. 78-53 W. 171.4 feet to an iron pin at the joint rear corner of Lots No. 9 and 16; thence running with the joint line of said lots, N. 29-39 W. 92.4 feet to an iron pin in line of property now or formerly of Parie Jones Green; thence with the line of said property N. 74059 E. 187.5 feet to an iron pin on the western side of Glenda Lane; thence with said lane S. 17-37 E. 7.9 feet to a point in the curve of Glenda Lane; thence continuing with said curve S. 12-23 W. 50 feet to a point; thence continuing with said curve S. 39-53 E. 34.5 feet to the point of beginning.

This being the identical lot of land conveyed to the grantor by Joseph A. Wells, as Trustee for the Orthodontic Associates, P. A.
