across the rear of the property as shown on the referred to Plat.

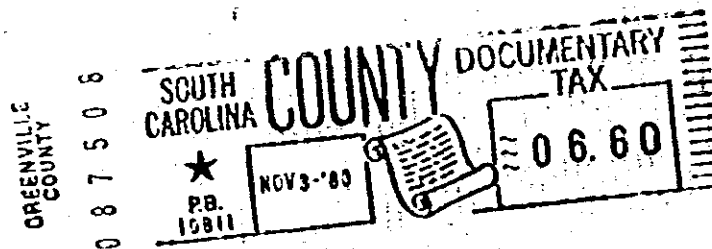
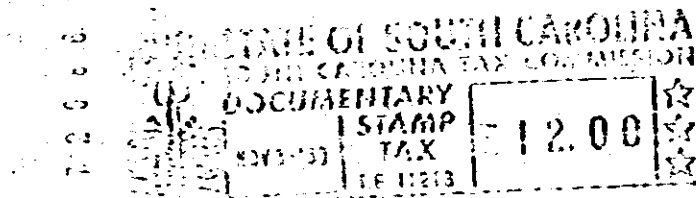
