sell and release unto

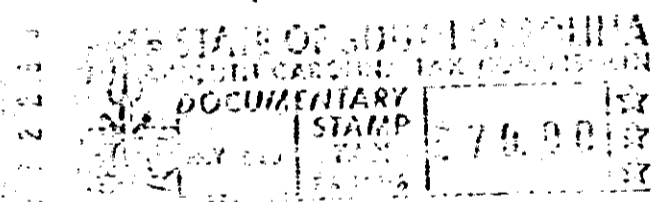
T.Z. Mitchell, his heirs and assigns, forever:
