POWER OF ATTORNEY

- (8) MY SAID TRUE AND LAWFUL ATTORNEY IN FACT, SHALL HAVE THE AUTHORITY TO DRAW FROM MY CHECKING ACCOUNT IN THE SOUTH CAROLINA NATIONAL BANK, THE AMOUNT OR AMOUNTS NECESSARY TO COMPENSATE HER OR HIS FEE AND EXPENSE IN EXECUTING THE ABOVE ACTIONS.
- (9) TO DO AND PERFORM ANY AND ALL OTHER ACTS NECESSARY OR INCIDENTAL TO THE PERFORMANCE AND EXECUTION OF THE POWERS HEREIN EXPRESSLY GRANTED WITH POWER TO DO AND PERFORM ALL ACTS AUTHORIZED HEREBY, AS FULLY TO ALL INTENTS AND PURPOSES AS THE GRANTOR MIGHT OR COULD DO IF PRESENT WITH FULL POWER OF SUBSTITUTION
- (10) THE PROVISIONS OF THIS POWER OF ATTORNEY SHALL TAKE EFFECT IF OR WHEN I SHOULD BECOME ILL TO THE EXTENT THAT I AM PHYSICALLY AND, OR MENTALLY UNABLE AND CANNOT HANDLE MY OWN AFFAIRS.
- (11) THIS POWER OF ATTORNEY SHALL CONTINUE IN FULL FORCE AND EFFECT UNTIL REVOKED BY OPERATION OF LAW OR OTHERWISE.

AND I, THE SAID RUTH A. RODGERS, DO HEREBY RATIFY AND CONFIRM ALL ACTS AND DEEDS PERFORMED UNDER THIS INSTRUMENT SHALL HAVE THE SAME FULL FORCE AND EFFECT AS IF PERFORMED AND SIGNED BY ME IN PERSON, AND,
