release unto Barbara D. Drummond, her heirs and assigns, forever:

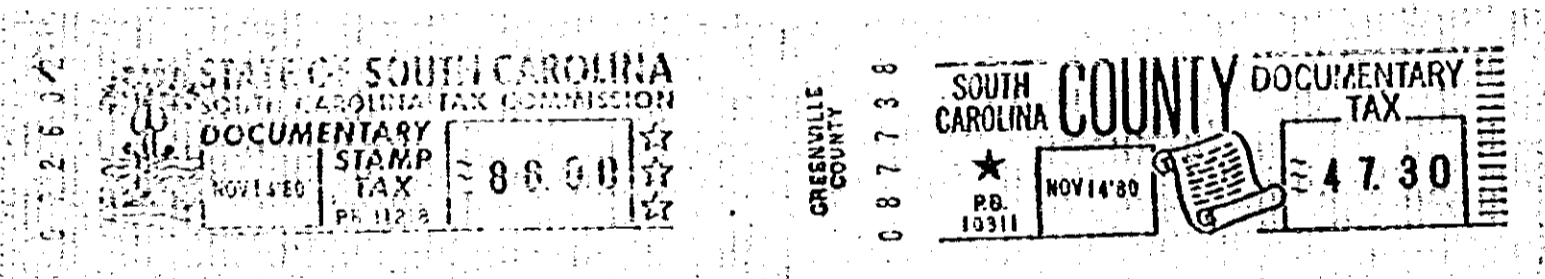
ALL that certain piece, parcel or unit, situate, lying and
