**DURABLE
POWER OF ATTORNEY**

I do further relieve any purchaser, mortgagee or any other person in the nature of a third party, coming into contact with this instrument, from any and all liability to check into the matter or to see to the use or application of any proceeds or any other matters pertaining thereto.

This power of attorney shall not be affected by physical disability or mental incompetence of the principal, which renders the principal incapable of managing the principal's own estate.
