ALL that piece, parcel or lot of land lying and being in the City of Travelers Rest, Greenville County, South Carolina, consisting of 2.4 acres, more or less, as shown on a plat thereof made by Carolina Surveying Company dated November 18, 1980 and entitled "Property of Larry Hughes and Linda W. Hughes", said plat being of record in Plat Book 8-F at Page 70 in the R.M.C. Office for Greenville County, South Carolina, and having, according to said plat the following metes and bounds:
