CORRECTIVE DEED

KNOW ALL MEN BY THESE PRESENTS, that WILLIAM R. FAIRBANKS

in consideration of One and no/100ths (1.00) and correction of deed Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THOMAS EDWARD HOLMES and STEPHANIE MORSE HOLMES, their heirs and assigns forever:

ALL those certain pieces, parcels or lots of land situate, lying and being on the northwest side of Jervey Road, in Paris Mountain Township, Greenville County, South Carolina, being shown as Lots 6 and 7 on plat of HILLDALE ESTATES made by Madison H. Woodward, Surveyor, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book B at page 145, and being more particularly described on a plat entitled "Foundation Survey for William R. Fairbanks", made by Arbor Engineering, dated July 30, 1980 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 8-A at page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Jervey Road at the joint front corner of Lots 5 and 6 and running thence along the line of Lot 5, N. 38-37 W. 365 feet to an iron pin; thence N. 51-30 E. 200.05 feet to an iron pin; thence along the line of Lot 8, S. 38-37 E. 387 feet to an iron pin on the northwest side of Jervey Road; thence along the northwest side of Jervey Road, S. 5746 W. 201.29 feet to the beginning corner.

As a part of the consideration of this conveyance the Grantees herein assume and agree to pay that mortgage indebtedness to South Carolina National Bank in the principal amount of \$53,150.00 as is recorded in the R.M.C. Office for Greenville County in Mortgage Book 1509 at page 341, having a present balance of \$53,097.40.
