All that certain piece, parcel or lot of land situate, lying and being in the Town of Travelers Rest, County of Greenville, State of South Carolina, and being known and designated as Lot No. 5 on Plat of the Estate of Maggie Love Howard, made by Terry T. Dill, and being more particularly shown as Tract No. 2 on Plat of property of Diamond Winter, Ltd., prepared by Freeland and Associates, dated December 23, 1980, recorded in the Office of the R.M.C. for Greenville County in Plat Book 8-1 at page 37, and having, according to said plat, the following netes and bounds:
