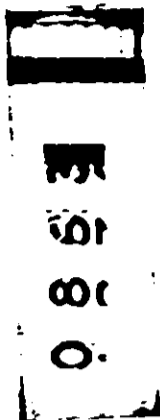
TRACT NUMBER 2:
