All our right, title and interest in all that lot of land in Greenville Township, Greenville County, State of South Carolina, near Judson Mills, known as Lot No. 21 on plat of property of H. B. Bates, recorded in Office of R. M. C. for said County in Plat Book F, page 32, having a frontage of fifty feet on the south side of Bates Street, with a depth in parallel lines of one hundred fifty feet, bound on the east by Center Street.
