O. Riddle, RLS, recorded in the Greenville County REC Office in Plat Book 201 at Page 102, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an old iron pin on the Southern edge of the right-of-way of a proposed unnamed street, at the joint corner of the within tract and Lot No. 10 and running thence along the joint line of the within tract and Lot No. 10, S. 34-22 W., 140 feet to an old iron pin at the joint corner of the within tract and Lots Nos. 9 and 10; thence running along the joint line of the within tract and Lot Nos. 9 and 8, S. 38-35 W., 225.0 feet to an old iron pin in the line of property of Chestnut Hills Subdivision; thence running along the line of property of Chestnut Hills Subdivision N. 15-29 E., 285.97 feet to an iron pin at the joint corner of the within tract and property now or formerly of Gilreath and Small; thence running along the joint line of the within tract and property now or formerly of Gilreath and Small, S. 55-50 E., 188.45 feet to a point on the edge of a cul-de-sac of a proposed unnamed street; thence with the Southern edge of said cul-de-sac, and along a curve to the right, the radius of which is 50 feet, the chord of which is S. 55-50 E., 86.60 feet and the arc of which is 104.72 feet to an old iron pin on the Southern edge of the right-of-way of a proposed unnamed street, at the
